Letter From the President

The STSA 58th Annual Meeting in San Antonio was a great event! Thanks to all who attended and made valuable contributions to the meeting's success. Attendee evaluation forms praised the quality of the educational programming and the unique social spirit that is such an important part of all STSA meetings. For the second year in a row we had record participation among exhibiting companies, and I hope most of you had an opportunity to spend some time in the exhibit hall, meeting with our industry colleagues. At the Business Meeting on Friday afternoon STSA welcomed 29 new Active Members and, with the approval of a recent bylaws change, an inaugural group of 11 Resident Members. 
