
# 2013 STSA Annual Meeting Award Recipients

The inaugural STSA Residents Scholarship will be awarded in 2014 to a general surgery or thoracic surgery resident committed to cardiothoracic surgery. Interested applicants must complete an online application and submit a current version of their CV, a letter of nomination from an STSA member, and a letter of support from their Program Director confirming their permission for the applicant to travel to Tucson November 6-9, 2014.

Both the Brooks Scholarship and STSA Residents Scholarship include airfare to attend the STSA 61st Annual Meeting November 6-9, 2014 in Tucson, Arizona; a three-night stay at the JW Marriott Tucson Starr Pass Tucson Resort & Spa; and reimbursement for travel-related expenses to attend the meeting. Scholarship recipients will also receive tickets to attend the President's Mixer and Annual Awards Dinner & Dance.
