TSF STSA Resident Research Award

STSA, in partnership with The Thoracic Surgery Foundation (TSF) offered the TSF STSA Resident Research Award, which provides operational support of original research efforts by general surgery or cardiothoracic surgery residents who have not yet completed cardiothoracic surgical training.

STSA is pleased to announce that the recipient of the 2019 TSF STSA Resident Research Award is Lillian L. Tsai, MD, for her research project titled, "An Implantable Microdevice for Personalized Chemotherapy to Prevent Recurrence in Non-Small Cell Lung Cancer." Dr. Tsai is a general surgery resident at Johns Hopkins Hospital.

Dr. Tsai's project will use an implantable microdevice to prevent recurrence in non-small cell lung cancer, using patient-derived xenografts to test and individualize therapy. Ultimately,

the team's goal is to insert this microdevice into patient tumors preoperatively, extract the device postoperatively, and personalize adjuvant chemotherapy to maximize survival.
